Due to extended 1969 production strike, 1970 production did not begin until January, 1970. Total build for 1970 was 17,316, lowest since 1962. Constitution by-law changes

The board got together and reviewed the constitution and bylaws, which is a requirement, and have come up with several changes.

Most of these changes have been discussed in meetings, but this will introduce the changes in the format that

is required. We can discuss and vote on these revisions at the February meeting providing there is a quorum. Additionally, there will be hard copies handed out The proposed changes are as follows:

Constitution

Article X- c. Article XI- b.

Propose changing the wording to the notifications to include newsletter and/or website.

Article XII- a.

Propose changing the transfer of assets in the case of WVCA dissolution to the discretion of the sitting board members.

By-Laws

Section 3.3-b.

To allow current members to maintain membership for 1 year after selling their Corvette, allowing time to acquire another Corvette.

Section 3.4 a-d.

Explains the member point system in clearer detail A. Members recognition points will receive one participation point for each of the following:

1. One point for a Attending a sanctioned event or activity - including meetings.

2.Wearing the Association jacket, name tag, hat, or shirt with approved WVCA logo at a sanctioned event - including meetings.

3. Wearing an association name tag at a sanctioned event or activity – including meetings, (Embroidered name on jacket is considered a name tag.)

4.Being a working member of an Association committee or event appointed by the president.

B. Members will receive two participation points for each of the following:

1. Organizing a sanctioned event or activity,

2. Promoting a sanctioned event or activity,

C. Members will receive three participation points for each of the following:


1. Hosting a sanctioned event or activity.

2. Being a chairperson of a committee for a sanctioned event or activity.

D. Ten members who have accumulated more points for participation than other members during a fiscal year will be Section 7.1 d. recognized by presentation of:

1. A certificate of appreciation, and

2. A pin, or something deemed appropriate by the outgoing board of directors.



Section 3.41

Clearer definition for member of the year selection.

A. Procedure for selecting a Member of the Year is:

1. A member who is one of the ten members receiving most points, as outlined in Section 3.4, will be designated: "Member of the Year."

a) WVCA directors will select the Member of the Year by majority vote.

b) Total meetings attended by a candidate may be considered when a tie must be broken in the total number of points considered for selection.

2. Members of the board of directors will not be eligible for Member of the Year because they choose who that member will be. A board member may be eligible for special recognition.

Section 3.42

Member of the Year recognition and awards defined

A. Award will be:

1. A plaque or something deemed appropriate by the board of directors.

a) Recognition and presentation will take place at WVCA's Year-end banquet.

b) Dues for a single member, family couple will be paid from the general membership fund for a year as an award.

c) A photo of a Corvette owned by the member of the year or family couple will be shown on the roster

Changes notification of nominations to include website.

D. The Glass Sass newsletter and/or website will publish the final list of nominees in the October issue.

Section 9.2

Changes password change requirement for website access

B.2.e Each member will have a personal password for access and the password can be changed at member's discretion.
