Corvette for Sale

Randy Stockberger - We have ordered a 2026 Corvette and need to sell our C7 Grand Sport.

It is a 2LT automatic coupe in Corvette Racing Yellow Tintcoat with a dark gray interior. We bought the car in the Fall of 2020 with 12,000 miles on it and it now has 47,800 miles and has run well. It has the standard Grand Sport features, Ground Effects, 6.2 Liter/460hp LT1 dry sump engine, 8 speed auto transmission with paddle shifters and mag ride shocks. The 2LT trim adds a premium sound system and the Heads Up display. In addition the car has ceramic brakes that are very effective and produce almost no dust and satin black ten spoke wheels with yellow brake calipers.

I would rate the cars' condition as Very Good. When researching prices I found private party sale prices that ranged from \$46K to \$72K. We are pricing this car at \$52K
